INSTRUCTIONS FOR PROFILE REGISTRATION AND REGISTRATION OF BRAND & LABEL NAME FOR IMFL FOR SALE IN MANIPUR

A. PROFILE REGISTRATION:

- 1. Any Distillery/ Manufacturer/ Distributor/ Bottler/ Company/ Firm having their office/unit outside Manipur and intends to sell their products in Manipur shall submit application for Profile Registration in Form A along with duly required documents. All documents must be sealed and signed by the authorised person.
- 2. The application form along with required documents shall be submitted both in physical to the Excise Office as per the address given below and through e-mail account namely excisemanipur@qmail.com.

Address: Office of the Commissioner of Excise, Manipur. Lamphelpat, Near DC Imphal West, Manipur -795004.

- 3. The following are the fees for Profile Registration which shall be submitted through Demand Draft from any nationalized bank only in favour of Excise Commissioner, Manipur payable at Imphal, and are valid for minimum 3 months:
 - a. Non-refundable Processing Fee of Rs. 5,000/- which shall be submitted at the time of submission of Application form.
 - b. Profile Registration/Renewal Fee of Rs. 5,00,000/-. For those whose Profile Registration are not approved, the Registration/Renewal Fee shall be refunded within 1(one) month of the received of the application form.
- 4. The Profile Registration fee levied is valid till 31st March of the financial year i.e. upto 31st March 2026.
- 5. Renewal of Profile Registration must be done before expiry by following the similar process, for those who wishes to continue to sell their products in Manipur.

B. REGISTRATION OF BRAND AND LABEL NAME:

- Any Distillery/ Manufacturer/ Distributor/ Bottler/ Company/ Firm having valid Profile Registration Certificate issued by Excise Department, Manipurand intention to sell their products in Manipur shall submit application for Registration of Brand and Label Name in Form – B along with required documents. All documents must be sealed and signed by the authorised person. Application copy for Profile Registration may be enclosed for those that have not received registration number at the time of submission of application.
- 2. Separate form must be submitted for each brand and label name.
- 3. The application form along with required documents shall be submitted both in physical to the Excise Office as per the address given below and through e-mail account namely excisemanipur@amail.com.

- 4. The following are the fees for Registration of Brand & Label Name which shall be submitted through Demand Draft from any nationalized bank only in favour of Excise Commissioner, Manipur payable at Imphal, and are valid for minimum 3 months:
 - a. Non-refundable Processing Fee of Rs. 5,000/- which shall be submitted at the time of submission of Application form.
 - b. The prescribed annual registration/renewal fee is as below:

- c. For those whose registration are not approved, the Registration/Renewal Fee shall be refunded within 1(one) month of the received of the application form.
- 5. The Registration fee levied is valid till 31st March of the financial year i.e. upto 31st March 2026.
- 6. For any change, addition or deletion of any mark or inscription on labels, fresh registration shall be done with deposit of prescribed registration fees.
- 7. Renewal of Registration must be done before expiry by following the similar process, for those who wishes to continue to sell their products in Manipur.
- 8. The following details must be printed in all the labels:
 - i. Brand name
 - ii. Alcoholic strength
 - iii. Measure in ml/litre
 - iv. Origin of the liquor;
 - v. Name and address of the distiller, compounder, blender and brewer and in respect of foreign liquor bottled in India, the name and address of the bottler;
 - vi. MRP, dates of manufacture and expiry in case of canned beer
 - vii. Batch Number of the liquor
 - viii. Ingredients, where ever applicable
 - ix. FOR SALE IN MANIPUR ONLY
 - x. BE SAFE DON'T DRINK AND DRIVE
 - **XI. CONSUMPTION OF LIQUOR IS INJURIOUS TO HEALTH**
 - xii. Profile Registration Number
 - xiii. Brand and Label Registration Number
 - xiv. FSSAI Registration Number
 - xv. Customer Care details
 - xvi. QR Code.
 - xvii. Any other details as and when decided by the Competent Authority which shall be informed in advance.
- 9. Each bottle to be affixed with Excise Adhesive Label provided by Excise Department, Manipur. Cost per EAL is Re. 0.85 only.
- Cartoon boxes per case shall also be labelled with necessary details. A mother QR
 Code to be generated for Track & Trace that shall carry the details of EAL for each
 bottle inside the box like mother and child.
