The Government of India has received a loan for financing from the New Development Bank toward the cost of the *Rejuvenation of Lamphelpat waterbody to alleviate urban flooding, providing sustainable water source for Imphal city and promoting eco-tourismProjectand* intends to apply part of the proceeds toward eligible payments under the contract¹ for construction of works as detailed below.

- Bidding will be conducted through International open competitive procurement using a Request for Bids (RFB) and is open to all Bidders as defined in the Procurement Regulations.
- 2. Reputed bidders, which are incorporated in any one of the NDB member countries (Brazil, Russia, India, China, South-Africa, Bangladesh and United Arab Emirates) should, however, be registered with the Government of India or other State Governments, or State/Central Government Undertakings. Bidders from India or any of the NDB member countries who are not registered as above, on the date of bidding, can also participate provided they get themselves registered by the time of contract signing, if they become successful bidders.
- 3. The Water Resources Department now invites online Bids from eligible Bidders for the construction of works detailed below in the table. The bidders should submit bids all of the works indicated therein. Interested bidders may obtain further information and inspect the bidding document at the address given below during office hours. Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III Evaluation and Qualification Criteria), to qualify for the award of the contract.
- 4. The bidding document is available online on https://manipurtenders.gov.in/nicgep/app from 08-10-2025 to 06-11-2025 for a non-refundable fee of Rs. 20,000/-, as indicated in the table below, is required to be paid online. Bidders will be required to register on the

- website. The bidders would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
- 5. For submission of the bid, the bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorised by Government of India for issuing DSC. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: https://manipurtenders.gov.in/nicgep/app.
- 6. Bids comprise two Parts, namely the Technical Part and the Financial Part, and both parts must be submitted simultaneously online on https://manipurtenders.gov.in/nicgep/app (website) on or before 1500 hours on 06-11-2025 and the 'Technical Part' of the bids will be publicly opened online on the same day at 1600 hours, in the presence of the bidders designated representatives who wish to attend. The "Financial Part" shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The electronic bidding system would not allow any late submission of bids.
- 7. All Bids must be accompanied by a Bid Security of the amount specified for the work in the table below, is required to be paid online. Bid security shall have to be valid for 45 days beyond the validity of the bid. Procedure for submission of bid security is described in Para 8.
- 8. The bidders are required to submit (a) original payment documents towards the cost of bid document; and registration on e-procurement website (if applicable); (b) original bid security; and (c) original affidavit regarding correctness of information furnished with bid document, before the bid submission deadline through online only.
- 9. A pre-bid meeting will be held on 17-10-2025 at 1:30 PM at the Office of the Superintending Engineer, Irrigation Circle –I, Water Resources Department, Government of Manipur (subject to changes as per convenience of the situation) to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITB Clause 7.4 of 'Instructions to Bidders' of the bidding document. Bidders are advised to download the bidding document prior to the pre-bid meeting in order for bidders to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
- 10. Other details can be seen in the bidding document. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to this bid.
