- Any hotel establishments with not less than 20 lodging-rooms operating in the State
 of Manipur and intending to sell foreign liquor "on" their premises shall submit
 application for licence in Form No. 13-A along with duly required documents. All
 documents must be sealed and signed by the authorised person.

- 5. The above licence-fees are valid for sale of foreign liquor 'ON" premises inside licensed hotels and restaurants attached to such hotels for sale of liquor from 11.00 AM to 9.00 PM. Such premises may be kept open upto 10.00 PM under a separate late closing licence fee as given at SI. No. 4 (v). above. Those establishments wishing to apply for late closing licence fee are to submit separate application fee for the same as given at SI.No. 3 (b) above.
- 6. The licence fee levied is valid till 31st March of the financial year i.e. upto 31st March 2026.
- 7. Renewal of licence must be done before expiry by following the similar process, for those who wish to continue to sell foreign liquor "on" their premises.
- 8. The fees for Licence shall be submitted through Demand Draft from any nationalized bank only in favour of Excise Commissioner, Manipur payable at Imphal, and are to be valid for minimum 3 months.
- 9. For those whose applications are not approved, the Licence Fee shall be refunded within 1(one) month of the receipt of the application form.
