ORDER

It may be mentioned that the preliminary hearing to record satisfaction for the purpose of issuing notices to National Socialist Council of Nagaland (Khaplang) [NSCN (K)] was held on 29.10.2025. The Ministry of Home Affairs and State of Nagaland were represented. After this Tribunal recorded its *prima-facie* satisfaction, directions were accordingly given by this Tribunal for service of notice on NSCN (K) by the Central Government and State of Nagaland. However, since NSCN (K) is also active in the States of Manipur and Arunachal Pradesh, as discernible from Notification No. S.O. 4241 (E) dated 22.09.2025, it is imperative that notices be also served on NSCN (K) by the State Government of Manipur and Arunachal Pradesh. Hence this hearing.

The Union of India is represented by Mr. S.C. Keyal, learned Special Counsel and Government of Arunachal Pradesh is represented by Shri Arun Chandran, Senior Government Advocate, Arunachal Pradesh. Government of Manipur is unrepresented.

However, Mr. S.C. Keyal, learned Special Counsel undertakes that the Ministry of Home Affairs, North East Division, Government of India will serve a copy of this order to the State of Manipur through the Chief Secretary of the State, for compliance of the directions of this Tribunal for service of notice on NSCN (K) by the State of Manipur.



The notice shall be served upon NSCN (K) in the following manner:

- (i) By Speed Post/Registered A/D at the last known addresses of NSCN (K) along with all its factions, wings and front organizations as well as that of its principal office bearers.
- (ii) Service of notice be also effected on the Office Bearers of NSCN (K) in Manipur and Arunachal Pradesh at its addresses, if any or if under detention, through the Superintendent (Jail) concerned.
- (iii) By publication along with a copy of the Gazette Notification dated 22nd September, 2025, in two daily newspapers, one in a National Newspaper (in English) and the other one in prominent local vernacular language newspaper, having wide circulation in the areas where the activities of the NSCN (K) are ordinarily carried on, within 14 days from today.
- (iv) By affixation of the notice along with a copy of the Gazette notification dated 22nd September, 2025, at the last known addresses of NSCN (K) along with all its factions, wings and front organizations as well as its principal office bearers.
- (v) By a proclamation by beating of drums as well as loudspeakers about the contents of the notice and the Notification dated 22nd September, 2025, in the areas in which the activities of the NSCN (K) were or are ordinarily carried on.
- (vi) By displaying the notice along with a copy of the Gazette notification dated 22nd September, 2025, on the notice board of the Deputy Commissioner, SDM and Superintendent of Police in all the district headquarters of the state(s) where the activities of the NSCN (K) were or are believed to be ordinarily carried on.
- (vii) Notice be also served on the State Government of Manipur and Arunachal Pradesh through its Chief Secretary.
- (viii) The Notice and the Gazette notification dated 22nd September, 2025, be also announced in the All India Radio/electronic media at the prime time and shall also be pasted at the prominent places in the States where the activities of NSCN (K) were or are believed to be carried on.





- (ix) By affixing copies of the notice at some conspicuous parts of the offices, if any, of NSCN (K).
- (x) By publishing on the website of Ministry of Home Affairs, Union of India and of the Department of Home and Political, Government of Manipur and Arunachal Pradesh.
- (xi) By any other possible modes, including e-mail etc.



The Central Government as well as the State Government of Manipur and Arunachal Pradesh shall make necessary and adequate arrangements for service of notice.

The report of service of the notice shall be submitted to the Registrar of the Tribunal on or before 12.12.2025 in the Office Chamber of the Deputy Registrar (Bench), 3rd Floor of Gauhati High Court (New Block), Guwahati, Mahatma Gandhi Road, Guwahati- 781001, Assam, duly supported by affidavits of the concerned officer(s)/official(s), who have effected the service along with supporting documents.

The Registrar of the Tribunal shall do the needful.

Meanwhile, the Central Government and the State Government of Manipur and Arunachal Pradesh will submit their respective affidavits and documents in support of the grounds on which the aforesaid Association has been declared as unlawful.

The next sitting of the Tribunal shall take place at Court No. 4, Gauhati High Court (New Block) Guwahati on 16.12.2025 at 2:00 P.M.

Copy of this order be given to Sri S.C Keyal, learned Special Counsel, Government of India and the officials of State Government of Manipur and Arunachal Pradesh for initiating necessary steps immediately, as per this order.

WHEREAS, the Central Government in exercise of the powers conferred by Subsection (1) of Section 3 of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967) (hereinafter referred to as 'The Act') has declared the National Socialist Council of Nagaland (Khaplang) [NSCN (K)] along with all its factions, wings and front organizations to be unlawful association with immediate effect from 28.09.2025 vide Notification No. S.O. 4241(E) (published in the Gazette of India, Extraordinary, Part-II, Section 3, Sub-section (ii) dated 22nd September, 2025).

AND WHEREAS, vide Gazette Notification No. S.O. 4709(E) dated 17th October, 2025, in exercise of powers under Section 5 (1) of the Act, the Central Government has constituted the Unlawful Activities (Prevention) Tribunal comprising of Hon'ble Mr. Justice Nelson Sailo, Judge, Gauhati High Court, for the purpose of adjudicating whether or not there is sufficient cause for declaring the said National Socialist Council of Nagaland (Khaplang) [NSCN (K)] as Unlawful Association as required by Sub-section (1) of Section 4 of the Act.

Now, therefore, a Notice is hereby given under Sub-section (2) of Section 4 of the Act read with Rule 6 of the Unlawful Activities (Prevention) Rules, 1968 and you are hereby called upon to show cause in writing within 30 days from the date of service of this Notice as to why the said National Socialist Council of Nagaland (Khaplang) [NSCN (K)] should not be declared as unlawful association and why an order should not be made confirming the declaration to the above effect made in the 31/10/2025 above mentioned Notification.

The objections/reply/written statement, if any, may be filed/delivered within the statutory period of 30 days from the date of service of the notice, before the Registrar of this Tribunal, *viz.*, the undersigned at the Chamber of the Deputy Registrar (Bench), 3rd Floor, Gauhati High Court, (New Building), Guwahati, Assam-781001. In case, objections/reply/written statements are in regional or vernacular language, true English Translation thereof should be also attached.

You are required to appear before the Tribunal or may cause an appearance on your behalf before the tribunal on 16.12.2025 at 2:00 P.M at Court No. 4, Gauhati High Court (New Block) Guwahati, Mahatma Gandhi Road, Guwahati-781001, Assam either through a duly authorized representative or an instructed Counsel/Advocate, whereafter irrespective of your appearance, the Tribunal shall proceed as per Sub-Section (3) of Section 4 of the Act.

The next hearing of the Tribunal is fixed on 16.12.2025 at 2:00 P.M at Court No. 4, Gauhati High Court (New Block) Guwahati.
