No.1/8/2018- MHRC (Law): This is for information to all interested persons in connection with filling up the following post in Manipur Human Rights Commission, for furnishing their applications along with required information as given below:

1.	Post:	Chairperson of Manipur Human Rights Commission.
2.	Number	01 (One)
3.	Terms of appointment	03(three) years from the date of entering upon his/her office and shall be eligible for re-appointment for another term of 03 (three) years, provided that no member shall hold office after attaining age of 70 (seventy) years [Section 24(2) of the Protection of Human Rights Act, 1993] (Ref.: Conditions under Section 24 of PHR Act are binding)
4.	Eligibility:	A person who has been a Chief Justice or a Judge of a High Court.
5.	Language requirement:	Working knowledge of English and Manipuri language.
6.	Salaries and Allowances:	Salaries and allowances will be governed by the Manipur Human Rights Commission (Salaries and Allowances and Other Terms and Conditions of service of the Chairperson & Members) Rules, 2004 as amended from time to time.
7.	Age limit:	Age of applicant shall be below 70 years. (Preferably not above 69 years of age on the date of submission of application)

Regarding the above, the relevant provisions under the Protection of Human Rights Act, 1993 will be applicable.

2) Required Information/ documents:

- (1) Application with full bio-data.
- (2) Scanned passport size photograph recently taken.
- (3) Scanned Aadhar card, up and down.
- (4) Copies of testimonials (scanned copies) (if any)

3) Interested persons may submit their application along with bio-data to the Principal Secretary (Law & Legislative Affairs), Govt. of Manipur in online mode only via e-mail to secy.law-mn@gov.in by 08-03-2026. No physical/ hard copy of application will be accepted.

4) It is to inform that, persons who have already applied for the post of Chairperson following Notification of even number dated 07.11.2025, may not submit fresh application. Their candidature will be considered subject to fulfilment of conditions, under the Act.
