No. 2/15/2018-Leg/L : The following Act of the Legislature, Manipur which received assent of the Governor of Manipur on March 12, 2018 is hereby published in the Official Gazette:

THE MANIPUR PUBLIC SERVICE COMMISSION (ADDITIONAL FUNCTIONS)  
SECOND AMENDMENT ACT, 2018  
(MANIPUR ACT NO. 4 OF 2018)

*further to amend the Manipur Public Service Commission (Additional Functions) Act, 2014 (Manipur Act No. 6 of 2014).*

BE it enacted by the Legislature of Manipur in the Sixty-ninth Year of the Republic of India as follows:-

1. (1) This Act may be called the Manipur Public Service Commission (Additional Functions) Second Amendment Act, 2018.

Short title and commencement.

(2) It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.

2. In section 2 of the Manipur Public Service Commission (Additional Functions) Act, 2014 (hereinafter referred to as the Principal Act), after clause (bb), the following new clause (bc) shall be inserted, namely:-

Amendment of section 2.

“(bc) “Government Society” means a society formed and owned by the State Government;”.

3. In section 3 of the Principal Act, for the words “local authority

and Government Company" wherever they occur, the words "local authority, Government Company and Government Society" shall be substituted.

4. For section 4 of the Principal Act, the following shall be substituted, namely,- Amendment of section 4.

**"4. Power to add or omit from the list of local authority, Government Company and Government Society.-** The State Government may, by notification in the Official Gazette, add or omit from the list of local authority or Government Company or Government Society specified in the Schedule-I or Schedule-II or Schedule-III respectively."


5. For clause (a) of sub-section (2) of section 5 of the Principal Act, the following shall be substituted, namely:- Amendment of section 5.

**"(a) the procedure to be followed by the local authorities, Government Company and Government Society for consultation with the Commission;"**

6. After SCHEDULE-II, the following SCHEDULE-III shall be inserted, namely:- Insertion of Schedule-III.
