At the end of TECHNICAL PART - Qualification PART A, [i.e. just before Technical Evaluation (ITB 32.4) PART B] following shall be added: The technical bid evaluation will be done in two parts – Part A & Part B in the manner detailed in this Section III - Evaluation and Qualification Criteria. Part A of Section III lays down Mandatory Qualification Criteria, like Financial Capability of the Bidder, Specific Experience of having executed similar Projects, other related experience and submission of specified documents etc. Bids will be evaluated under Part A on Pass/Fail basis. A bidder which passes Part A of Technical Evaluation shall be considered for further evaluation under Part B. Part B of Technical Evaluation in Section III lays down scoring methodology for various technical factors, non-price factors, and sub factors which for purpose of this RFB carry the same meaning as Rated Criteria. Various Sub-factors of the Technical Factors (Rated Criteria) are detailed in Technical Part B of Section III of the RFB, with their respective maximum scores.
