## NOTIFICATION

Imphal, the 23rd May, 2017

No. 2/7/2016-MAHUD: Whereas, the Governor of Manipur in exercise of the powers conferred under Sub-Section (1) of Section 3 of the Manipur Municipalities Act, 1994 had signified his intention to declare the whole of notified area in respect of Samurou Nagar Panchayat and Thongkhong Laxmi Nagar Panchayat in Imphal West District to be Municipal Councils vide Government Notifications of even No. dated 26-12-2016 and No. 2/7/2016-MAHUD/1 dated 26-12-2016;

2. And whereas, it had been ordered under Sub-Section (3) of Section 3 of the Manipur Municipalities Act, 1994 that the existing Ward wise boundaries of the aforesaid Nagar Panchayats and the boundaries of the notified area along with the same existing member of Wards, when upgraded to a Municipal Council, will be retained without any change vide Government Notifications of even No. dated 26-12-2016 and No. 2/7/2016-MAHUD/1 dated 26-12-2016.

3. And, whereas, as required under sub-section (4) of Section 3 of the Manipur Municipalities Act, 1994, it was notified that any person who is ordinary resident of the notified area of the above Nagar Panchayat may if he/she objects to anything contained herein, submit for objection in writing to the Deputy Commissioner, Imphal West District within 45(forty-five) days from the date of publication of the said Government Notifications of even No. dated 26-12-2016 and No. 2/7/2016-MAHUD/1 dated 26-12-2016;

4. And, whereas, the office of the Deputy Commissioner, Imphal West vide their letter No. DC (IW)/7/3/NP-Samu/2017/137 dated 05-05-2017 and No. DC (IW)/7/2/THLax-MC/2017/136 dated 05-05-2017 had reported that no written objection from anybody in connection with the declaration of Samurou Nagar Panchayat and Thongkhong Laxmi Nagar Panchayat in Imphal West District to be Municipal Councils had been received;
