NOTIFICATION
Imphal, the 27th May, 2019

No. 2/1/2017-MAHUD: Whereas, the Governor of Manipur in exercise of the powers conferred under Sub-Section (1) of Section 3 of the Manipur Municipalities Act, 1994 had signified his intention to declare the whole of notified areas in respect of the Lilong (Imphal West) Nagar Panchayat in Imphal West District to be a Municipal Council vide this Government Notification of even No. dated 27th November, 2018;

2. And whereas, it had been ordered under Sub-Section (3) of section 3 of the Manipur Municipalities Act, 1994 that the existing Ward wise boundaries of the aforesaid Nagar Panchayat and the boundary of the notified area along with the same existing member of Wards, when upgraded to a Municipal Council, will be retained without any change vide this Government Notification of even No. dated 27th November, 2018;

3. And, whereas, as required under Sub-Section 4 of Section 3 of the Manipur Municipalities Act, 1994, it was notified that any person who is ordinarily resident of the notified area of the above Nagar Panchayat may if he/she objects anything contained herein, submit for objection in writing to the Deputy Commissioner, Imphal West within 45 (forty-five) days from the date of publication of the said Government Notification of even No. dated 27th November, 2018;

4. And, whereas, the office of the Executive Officer, Lilong (Imphal West) Nagar Panchayat vide their letter No. 1/1/19-LIWNP dated 15th May, 2019 had reported that no written objection from anybody in connection with the declaration of Lilong (Imphal West) Nagar Panchayat in Imphal West District to be a Municipal Council had been received;

5. Now, therefore, the Governor of Manipur, in exercise of the powers conferred under Sub-Section (1) of Section 3 of the Manipur Municipalities Act, 1994, is pleased to declare the whole of notified area in respect of the Lilong (Imphal West) Nagar Panchayat in Imphal West District to be a Municipal Council with effect from the date of publication of this Notification in the official gazette.

WARDWISE BOUNDARY DESCRIPTION OF THE
PROPOSED LILONG (IMPHAL WEST) NOTIFIED AREA

WARD No. 1

Start from North Western corner of C.S. Dag No. 1386 of Village No. 67-Kunja Sheet No. 2 towards the South West reach Dag No. 1340 then turn towards the East and South and reach Dag No. 1263 again turned towards the East directly till the reach of South Eastern corner of Dag. No. 1584. Again turn to the North directly upto North Eastern corner of Dag No. 1454. Again turned towards the West reach North Western corner of Dag. No. 1385 turned towards the West and reach the starting place North Western corner of Dag. No. 1385 Langthabal Kunja Sheet No. 2 Village No. 98 Chajing.

WARD No. 2

Start from the North Western corner of Dag No. 1044 of Village No. 98 Cajing Sheet No. 1 towards the South Western corner of Dag No. 1059 then towards the East till to South Eastern corner of Dag. No. 1071 then turn to the North and reach South Western corner of Dag. No. 1495. Again turned towards the East directly and reached South Eastern corner of Dag. No. 1246. Again turned towards the North directly till the reach of North Eastern corner of Dag. No. 1485. Again turned towards the West and reached South Eastern corner and South Western corner of Dag. No. 1559 then turn to the West till the starting point of North Western corner of Dag. No. 1014 Chajing Village No. 98 Sheet No.

WARD No. 3

Start from the North Eastern corner of Dag. No. 643 of Village No. 70 Chajing Sheet No. 1 to the Southward and run up to the South Western corner of Dag. No. 675 (sic) and stop and then turn to the Eastward near the Eastern side of Chajing Lakpa Hill and then turn to the South directly till the end of Dag. No. 853 i.e. South Eastern corner of the said Dag then turn towards the West and comes until the South Western corner of Dag. No. 837. Again turned to the North and reached North Western corner of Dag No. 810 then turned to the Eastward and turned towards the northward No. III Eastern side of the Chajing Lakpa Hill then turn to the North directly upon the Village footpath till the North Eastern corner of Dag. No. 701 then turned towards the West and reach the North Western corner of Dag. No. 643 of Village No. 70 Chajing part -II Sheet No. 1

WARD No. 4

Start from the North Western corner of Dag. No. 1294 of Village No. 98 Chajing (Ward No. 4) towards the South and reach S/W corner of Dag. NO. 1305 then turn to the East towards till the reach S/W corner of Dag. No. 1343. Then turned to the South towards till the reach S/W corner of Dag. No. 1347 then turn East and run North towards till the reach S/E corner of Dag. No. 1345. Again come to the East towards till the reach N/E corner of

Dag. No. 1348 then turn to the North and run towards will the reach N/E corner of Dag No. 1350 then turned to the North uptill the reach S/W corner of Dag. No. 1388. And turn t the East till the reach S/W corner Dag. No. 1389 and turn till the reach S/W corner of Dag. No. 1391 and run to the East till the reach S/W corner of Dag. No. 1406 then turned to the South towards till the reach S/W corner of Dag. No. 1404 and turn to the East and comes again to the North Till the reach S/W corner Dag. No. 1432 and turned to the East till the reach S/E Corner of Dag. No. 1408 and stop. Again come towards the North and run in the way of Imphal river left side and crossed right side of Indo Burma Road till the reach N/W corner of Dag. No. 1469 then turn to the South and run to the East towards till the reach S/W corner Dag. No. 1441 and comes North, then turned to the West till the reach S/E corner of Dag. No. 1444 then turn to the north and comes again the West till the reach of N/W corner of Dag No. 1443 and stop. Again comes to the North right side of Indo Burma Road and crossed left side till the reach N/W corner Dag. No. 1252 and run toward till the reach N/W corner of Dag. No. 1452 then turn to South till the reach N/E corner of Dag. No. 1265 then turn to the west on the Inter Village Road towards till the reach N/W corner of Dag. No. 1294 of Village No. 98 Chajing (Ward No. 4)

WARD NO. 5

Start from the North Western corner of Dag. No. 800 Village No. 70 to the Southward and run upto South Western corner of Dag. No. 751 then turned to the right and comes Eastward then comes near the bank of Imphal river till the reach of South Eastern corner of Dag. No. 897 and stop. Again turns to the Northward till the reach of North Eastern corner of Dag. No 885 and stop again comes upto the Westward the village path till the reach of North Eastern corner of Dag. No. 800 of Village No. 70 Chajing.

Ward NO. 6

Start from the North Western corner of Dag. No. 1 of Village No. 71 Karam to the Southward directly till the reach of South Western corner of Dag. No. 77 (sie) then turned towards the East and stop. Again turned towards South till the reach of North Western corner of Dag. No. 120 then turned to the South till the reach of North Western corner of Dag. No. 133 then turned to the West and reach to the North Western corner of Dag. No. 145 then turned towards the South until the reach of South Western corner of Dag. No. 145 near the bank of Imphal River and stop. Again turned to the left and run towards the East and run on the way of Imphal river left side untill the reach of North corner of Dag. No. 1 of Village No. 71 Karam Ward 7 of village No. 67 Langthabal Kunja.

Ward No. 7

Start from the North of the Dag. No. 1213 towards South and comes near the foot of the Khoubum Hill and reach North Western corner Dag. No. 1213 again comes near foot of the Khoubum Hill and proceed again till the reach of South Western corner fo Dag. No. 1255 known as Toupokpi Lampak then turned to the Eastwards and reach Dag. No.
