No.BBL-101/1/2024-MAHUD-MAHUD-Part(1): Whereas, Town Planning Department, Manipur is in the process of amending the existing Imphal Municipal Corporation Building Bye-laws, 2013 to incorporate the changes recommended by the Ministry of Housing & Urban Affairs, Government of India and whereas the existing building bye-laws of (1) Bishnupur, (2) Jiribam, (3) Kakching, (4) Mayang Imphal, (5) Moirang, (6) Ningthoukhong, (7) Nambol and (8) Thoubal which was introduced based on Model Building Bye-laws of 1998 has not been updated since many years.

And, Whereas, there are no building bye-laws in-force in the remaining ULBs viz., (1) Andro, (2) Heirok, (3) Kakching Khunou, (4) Kumbi, (5) Kwakta, (6) Lamlai, (7) Lamshang, (8) Lilong (IW), (9) Lilong (Thoubal), (10) Oinam, (11) Samurou, (12) Sekmai, (13) Shikhong Sekmai, (14) Sugnu, (15) Thongkhong Laxmi, (16) Wangjing Lamding, (17) Wangoi & (18) Yairipok and Master Plan/ Notified Areas of Manipur (Urbanizable areas within a Master Plan boundary indicated in the Master Plan of a Town but beyond the municipal limits).

And, Whereas, Building Bye-Laws are legal tools used to regulate coverage, height, building bulk, and construction aspects of buildings so as to achieve orderly development of an area. This bye-law is mandatory in nature and serve to protect buildings against fire, earthquake, noise, structural failures and other hazards.

And, Whereas, Notice inviting objections and suggestions on the proposed bye-law was notified vide Notification No. BBL-101/1/2024-MAHUD-MAHUD(Part-1) dated 29.10.2024 and published in 4 (four) local dailies and Town Planning Department website.

And, Whereas, all the objections/suggestions received was placed before the Committee for examination/disposal of the objection/suggestions on the proposed bye-law. The recommendations of the Committee have been incorporated in the bye-law.

Now, therefore, the Governor of Manipur in supersession of all previous orders/notifications issued in this regard is pleased to accord approval for publication of the aforesaid "The Model Manipur Unified Building Bye-Laws, 2024" under Section 213 of the Manipur Municipalities Act, 1994 (Act No 43 of 1994) and Section 26(1) of the Manipur Town & Country Planning Act, 1975 (Manipur Act 11 of 1975) for adoption by the Urban Local Bodies and Planning & Development Authority, Manipur and the same is hereby published for general information as ANNEXURE. No. LDM-101/26/2023-REV-REVENUE: In exercise of the powers conferred Under Section 14 (2) of MLR & LR Act, 1960 read with rule 18 of the Manipur Land Revenue and Land Reforms (Allotment of Land) Rules, 1962 and as per the approval of State Cabinet, the Governor of Manipur is pleased to allot the land specified in Annexure - A to the Executive Officer, Wangoi Municipal Council and Executive Officer, Thongkhong Laxmi Municipal Council, Imphal West for construction of Segregation shed cum transfer station and 5 Solid Waste processing facilities.

2. The allotment is made subject to the following:-

- I. The allottee shall pay a token premium of Rs. 7,040/- (Rupees Seven thousand and forty only) @ Rs. 1000/- per acre as fixed by the state Government vide order no. 4/10/ALLOT/2013-Com(Rev) dated 2nd September, 2013 and the premium amount shall be credited to Major Head: 0029- Land Revenue on behalf of the Commissioner/ Secretary (Revenue), Government of Manipur within a period of 3 (three) months.
- II. The allottee shall execute a deed of allotment with Deputy Commissioner, Imphal West, Manipur.
- III. The Road side reserve prescribed under Rule 13 of MLR & LR (Allotment of Land) Rules, 1962 shall be maintained.
- IV. The SDC concerned shall demarcate the land and hand over to the allottee after execution of deed of allotment with Deputy Commissioner, Imphal West, Manipur.
- V. In the event of land being used for any purpose other than that for which it has been allotted, appropriate action shall be taken as laid down under Rule 18 (iii) (iv) & (v) of the MLR & LR (Allotment of Land) Rules, 1962.

And, whereas, as required under sub-section 4 of Section 3 of the Manipur Municipalities Act, 1994, it was notified that any person who is ordinarily resident of the notified area of the above Nagar Panchayat may if he/she objects to anything contained herein, submit for objection in writing to the Deputy Commissioner, Imphal West District within 45(forty-five) days from the date of publication of the said Government Notification of even No. dated 10-11-2011;

4. And, whereas, the office of the Deputy Commissioner, Imphal West and SDO, Wangoi vide their letters No.DC(TW)/1/CON/307/Misc/10 dated 17-04-2012 and No.6/SDO/W/Elec/MC-NP-2005 dated 26-03-2012 respectively had reported that no written objection from anybody in connection with the declaration of WangoiNagar Panchayat in Imphal West District to be a Municipal Council had been received;

5. Now, therefore, the Governor of Manipur, in exercise of the powers conferred under Sub-Section (1) of Section 3 of the Manipur Municipalities Act, 1994, is pleased to declare the whole of notified area in respect of the WangoiNagar Panchayat in Imphal West District to be a Municipal Council with effect from the date of publication of this Notification in the official gazette.
