NOTIFICATION

Imphal, the 20th October, 1983

No. 3/3/78-LSG(NA).—Whereas it appears to the Governor of Manipur that re-organisation of the existing area of the Thongkhong Laxmi Bazar Small Town Committee is necessary;

2. And, whereas the Governor by Notification of even number dated 22-8-83 has signified his intention to re-organise the said Thongkhong Laxmi Bazar Small Town Committee to include some of the areas which are contiguous as defined in the schedule below;

3. Whereas, no objection has been received within the specified period against the proposed re-organisation;

4. Now, therefore, in exercise of the powers conferred by clause (b) of Sub-section (1) of Section 3 of the Manipur Municipalities Act, 1976, the Governor of Manipur is pleased to re-organise the said Thongkhong Laxmi Bazar notified area.

Further, in exercise of the powers conferred by Section 11 of the Manipur Municipalities Act, 1976, read with rule 3 of Manipur Constitution of Small Towns and Conduct of Election in Small Towns Rules, 1972, the Governor of Manipur is pleased to divide the re-organised Thongkhong Laxmi Bazar Notified Area into 11 Wards as per schedule below the purpose of election of members of the aforesaid Small Town Committee.

SCHEDULE

**THE RUNNING BOUNDARY DESCRIPTIONS OF THE WARDS OF
THONGKHONG LAXMI BAZAR NOTIFIED AREA**

Commencing from north western corner of C.S. Dag No. 3003 of village No. 85 (Wangoi Top) and the line comes eastwards upto the north western corner of Dag No. 1109 by touching the northern side of Dag No. 3029 and 1182, 1120 & 1171. Then the line again comes north east corner to reach the northern side of Dag No. 2085 by touching northern side of Dag No. 1131, 1142, 1150, 2015 and 2135 etc. Then the line seems northwards until to reach the

north eastern corner of Dag No. 65 Wangoi Top, by touching the western side of Dag No. 284, 270, 102, 113 and 84. And then comes north and eastern side to reach south western corner of Dag No. 55 b crossing Mayang Imphal Road and comes northwards until to reach of north west of Dag No. 10 of Thiyam Leishangkhong village No. 86 by touching northern side of Dag No. 44 and 30 the line comes a slight eastwards and then comes southwards by zig-zag line until to reach the south western corner of Dag No. 5 Heiningsoi village No. 93 by touching western side of Dag No. 6, 80, 197, 274, 343, 406, 510 of Laku Huidrom village No. 84 then the line runs eastwards along the Mutum Phibou Road, and then the line comes northwards to reach the north eastern corner of Dag No. 198 of village No. 80 Mutum Phibou and comes along the southwards of Imphal river bank until the reach of south east corner of Dag No. 1636 and then the line comes westwards until to reach north east corner of Dag No. 58 of Mutum Phibou by a Zig-zag line by touching western side of Dag No. 1319 and 1095 then the line turns by southwards by Zig-zag line until to reach north west corner of Dag No. 1266 by touching northern side of Dag No. 32 and 20 of village No. 93 (Heiningsoi) and then the line runs westwards until to reach the westwards corner of Dag No. 3141 by crossing Mayang Imphal Road Dag No. 1317 of village No. 89 (Laku Huidrom) and touching northern side of Dag No. 1338 and 3172 of village No. 85 (Wangoi Top). Then the line comes a slight south and westwards until to reach the south western corner of Dag No. 3071 of Wangoi Top by touching northern side of Dag No. 3196, 3025 and 3076 then runs northwards until to reach the starting points.

WARDWISE BOUNDARY DESCRIPTIONS OF THONGKHONG LAXMI BAZAR AS A NOTIFIED AREA

Ward No. 1: The boundary description of the ward No. 1 is starting from the south eastern corner of the C.S. Dag No. 2154 of village No. 85 Wangoi Top and runs eastward by crossing Mayang Imphal Road. Then the line meet eastern corner of Dag No. 265 (paddy field Lungpuzai Kabui) and then comes northwards along the Leishangkhong Maril upto the northern side of Dag No. 282 of village No. 86 Thiyam Leishangkhong. Then the line runs westwards and meets eastern side of the Dag No. 2054 of the village No. 85 Wangoi Top by crossing Mayang Imphal Road and then runs a Zig-zag line upto the north western corner of Dag No. 2138. Then it runs towards southwards and meets south western corner of Dag No. 2233 and then comes eastwards by a slight bent line to reach the starting point.

Ward No. 2: The line covered by the ward No. 2 is starting from the north eastern corner of the C.S. Dag No. 2187 of the village No. 85 Wangoi Top and then the line runs westwards to reach the south western corner of the Dag No. 2135 and then runs south western by touching the north western corner of Dag No. 2320 and then meet south western corner of the Dag No. 1168 and then runs eastwards upto the south eastern corner of Dag No. 2327 and again runs a Zig-zag line along with the Zig-zag line and meet north eastern side of Dag No. 2234 and then runs northwards along the boundary line of the ward No. 1 and meet the starting point.

Ward No. 3: This boundary line is starting from the north eastern corner of the C.S. Dag No. 3130 of the village No. 85 Wangoi Top and runs westwards to get meet the north western corner of the Dag No. 3190 and then comes northwards and again meet south western corner of the Dag No. 1173. Then the line

runs westwards by touching the north western corner of Dag No. 1120 along the Salam of the Salam Loukon of Dag No. 3001 and then runs southwards along the Samushang road and meet again southern corner of Dag No. 3072. Then the line comes eastwards along the Tabaksoi Khong.

Ward No. 4: Starting from south western corner of Dag No. 3171 of village No. 85 Wangoi Top Patta land of Amina Bibi (paddy field) and runs eastwards and meet eastern side of Dag No. 1322 patta land of Abdul Salam paddy field of village No. 84 Laku Huidrom by touching southern side of Dag No. 2373 and south western corner of Dag No. 2392. Then it runs westwards and meet south eastern corner of Dag No. 2270 of Wangoi Top and comes by a Zig-zag line and meet south eastern corner of Dag No. 2416. Then runs westwards and meet north western corner southern boundary of ward No. 2 and meet north eastern boundary of Dag No. 1173 of ward No. 3 and runs south eastwards along the north eastern boundary of the same ward No. 3 and then meet the starting point.

Ward No. 5: Starting from the Dag No. 1252 patta land of Th. Joychandra Singh paddy field of village No. 84 Laku Huidrom. Then it runs north eastwards and meet north eastern corner of Dag No. 1144 of Laku Huidrom by touching the eastern side of Dag No. 1264 and then comes westwards and meet Mayang Imphal Road and runs northwards along the Mayang Imphal Road and meet north eastern corner of Dag No. 1369 and runs south and westwards and meet north western corner of Dag No. 1176 and runs southwards along the south eastern boundary of the ward No. 2 and meet north western corner of Dag No. 2255 of Wangoi Top and then runs north eastern boundary of the ward No. 4 and then meet the starting point.

Ward No. 6: Starting from the Dag No. 1264 of village No. 84 Laku Huidrom, patta land of L. Lukhoi Singh, paddy field. Then it runs south eastern side and meet north eastern corner of Dag No. 32 and runs a slight Zig-zag line and meet north eastern corner of Dag No. 18 of village No. 93 Heiningsoi and then comes north and eastwards and meet north eastern corner of Dag No. 503 and then runs westwards and meet north eastern corner of Dag No. 489 of Laku Huidrom, patta land of Kh. Ibobi Singh and meet Thambalkhong Maril and then runs south and westwards and meet north eastern corner of Dag No. 1072 and meet Mayang Imphal Road. Then it runs southwards along the Mayang Imphal Road and meet south western corner of Dag No. 1135 and then runs along the north eastern boundary of the ward No. 5 and then meet the starting point.

Ward No. 7: The line starts north western corner of Dag No. 56 of village No. 93 Heiningsoi and moves eastwards and meet south western corner of Dag No. 1067 and moves southwards. Then it meets south eastern corner of Dag No. 201 by touching north western corner of Dag No. 132 and 149. Then it runs southwards near the right bank of Imphal river and meet south western corner of Dag No. 1319 of Mutum Phibou by touching south eastern corner of Dag No. 1310. Then it moves eastward and meet north eastern boundary of Dag No. 1066 and then moves westward. Then it meet the south western corner of Dag No. 55 and then run northwards and meet the starting point.

Ward No. 8: The line starts from south western corner of the Dag No. 8487 patta land of Yumnam Indra Lukhrabi of Inghol class of village Laku Huidrom. Then it runs eastwards and meet the south eastern corner of Dag No. 510 patta land of Yumnam Chaoyaima Singh. Then the line runs northwards

and meet the north eastern corner of the patta of Yumnam Sajou by touching Dag No. 387 patta of Yumnam Angahal and Iboton. Then it runs westwards along the Thambalkhong Maril and moves southwards along the Khong and meet the starting point.

Ward No. 9: Starting from the south eastern corner of the Dag No. 219 patta land of Longjam Ibochouba Singh of Ingkhol class of the village No. 86 Thiyam Leishangkhong. Then it runs northwards along the Thambalkhong Maril and meet north eastern corner of Dag No. 129 patta land of Thingujam Konyai. Then the line moves westwards and meet north western corner of Dag No. 113 patta land of Mera Naga. The line moves southwards by crossing Mayang Imphal Road and meet the south western corner of Dag No. 284, patta land of Thingujam Chaoba Singh of Ingkhol class. Then it moves eastwards by a slight bent and then meet the starting point.

Ward No. 10: The line starts from the south western corner of the C.S. Dag No. 265 patta land of Laipubam Mani Sharma's Ingkhol of Laku Huidrom village No. 84. Then it runs eastwards and meet the eastern corner of Dag No. 274 patta land of Yumnam Jadu Singh. Then it runs northwards and meet the north eastern corner of Dag No. 5 patta land of Thiyam Kanhai Singh by touching eastern corner of Dag No. 90 patta land of Huidrom Nodiachand Singh. West and northwards and meet the north eastern corner of Dag No. 12 patta land of Thiyam Kanhai Singh. Then it moves southwards and meet south western corner of Dag No. 3 patta land of Thiyam Kanhai Singh of Laku Huidrom. Then the line moves southwards along the Thambalkhong Maril and then meet the starting point.

Ward No. 11: The line starts from the north eastern corner of Dag No. 129 of the village No. 86 Thiyam Leishangkhong patta land of Thingujam Konyai Singh. Then it runs northwards along the Thambalkhong Maril and meet south western corner of Dag No. 12 patta land of Thiyam Kanhai Singh and then north eastern corner of Dag No. 10 patta land of Asem Tamphajao Singh and then moves with a slight bent. And meet south western corner of Dag No. 7 patta land of Laipubam Rajbapu Sharma and then runs south and eastwards and meet north western corner of Dag No. 30 patta land of R.K. Tombisana Singh. Then the line comes towards southwards and meet north eastern corner of Dag No. 298 patta land of Langpujei Kabui of four class and crossed Mayang Imphal Road. And comes a slight Zig-zag line and meet the north western corner of Dag No. 65 patta land of Adhikarimayum Gournityai Sharma and comes north and westwards and meet the north eastern corner of Dag No. 123 patta land of Gopalung Naga's Ingkhol and the line comes eastwards and meet the starting point by crossing Mayang Imphal Road.
