No. 5/48/2022-Case/L(HC): WHEREAS the Hon'ble High Court of Manipur has passed common judgment & order dated 23.12.2025 in WP (C) No. 594 of 2022 (Chabungbam Thoibisana Devi -versus- The State of Manipur & Ors) and WP (C) No. 600 of 2022 (Lamneichong Haokip -versus- The State of Manipur & Ors.) and has set aside the seniority list of Assistant Public Prosecutor -cum- Assistant Government Advocate notified vide notification No. GAP-3/5/2021-SEC-LAW dated 22.07.2022.

AND WHEREAS, the Hon'ble Court has held that seniority as reflected in the Order No. 7/13/2015-GA/L (B) dated 02.12.2016 of regularization shall be the final seniority list of Assistant Public Prosecutors-cum-Assistant Government Advocates (District), Manipur as the same has been in order of years of initial appointment.
