NOTIFICATION
Imphal, the 2nd December, 2021

No. 1/9/21-RR(E/S)/DP: In supersession of all previous rules issued in this regard and in exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following rules regulating the method of recruitment to the post of **Lecturer of Higher Secondary Schools** under the Department of Education (School), Government of Manipur as shown in the M.P.S.C. Form-8, namely:-

1. **Short title:-** These rules may be called the Education (School) Department, Government of Manipur **Lecturer of Higher Secondary Schools** Recruitment Rules, 2021.
2. **Application:-** These rules shall apply to the post specified in column 1 of the M.P.S.C. Form-8 hereto annexed.
3. **Classification, Scale of pay, method of recruitment etc.:-** Classification of the said post, scale of pay, method of recruitment and other matters connected therewith shall be as specified in the columns 3 to 13 of the said MPSC Form-8.
4. **Disqualifications:-**
 - (a) No person, who has more than one wife living or who having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment to the aforesaid post, and
 - (b) No woman, whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment to the said post.

Provided that the Governor of Manipur may, if satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

5. "Power to relax- Where the Governor is of opinion that it is necessary or expedient so to do, he may order, for reasons to be recorded in writing, and in consultation with the Manipur Public Service Commission, for relaxation of any of the provisions of these rules with respect to any class or category of persons or posts."
6. These rules shall come into force with effect from the date of publication in the Manipur Gazette.

**RECRUITMENT RULES FOR THE POST OF LECTURER OF HIGHER
SECONDARY SCHOOLS UNDER EDUCATION (SCHOOL)
DEPARTMENT, MANIPUR**

1.	Designation of Post(s)	Lecturer of Higher Secondary Schools
2.	No. of Post(s)	All posts of Lecturers of Higher Secondary Schools
3.	Classification	GC.S. Group-B (Gazetted)
4.	Scale of Pay	Level-9 in Pay Matrix Level-12 (Sr. Scale after 12 years of regular service in the Grade).
5.	Whether selection post or non-selection post	Selection.
6.	Age for direct recruits	Minimum : 18 years Maximum : 38 years (Upper age limit is relaxable for Govt. servants appointed under the Government of Manipur to the extent of the period of continuous services put in the post/service and by 5 years for SC/ST candidates and by 3 years for OBC candidates and a Government servant who belongs to SC/ST will get the facility admissible to a Government servant in addition to the relaxation admissible to SC/ST candidates).
7.	Educational and other qualifications required for direct recruits	ESSENTIAL: 1. Post Graduate Degree holders with at least 50% or equivalent marks in the following 23 subjects concerned from a recognised University/Institute: i. Anthropology, ii. Bengali, iii. Botany, iv. Chemistry, v. Commerce, vi. Computer Sc., vii. Economics, viii. Education, ix. Engg. Drawing, x. English, xi. Geography, xii. Geology, xiii. Hindi, xiv. History, xv. Home Sc., xvi. Manipuri, xvii. Maths., xviii. Philosophy, xix. Physics, xx. Political Sc., xxi. Sociology, xxii. Statistics and xxiii. Zoology. 2. B.Ed. or B.A. B.Ed. or B.Sc. B.Ed. from a recognised Institute.

8.	Whether age and educational qualification prescribed for the direct recruits will apply in the case of promotees	Age : No Ednl. Qlfn.: Yes
9.	Period of probation, if any	2 (two) years
10.	Method of recruitment whether by direct recruitment or by promotion or by deputation/transfer & percentage of the sanctioned post to be filled by various methods	50% by promotion and 50% by direct recruitment.
11.	In case of recruitment by promotion/deputation/transfer, grades from which promotion/deputation/transfer to be made	Graduate Teachers holding Master's Degree with 5 years regular service in the grade and possessing the qualifications prescribed for direct recruits.
12.	If a DPC exists, what is its composition	Class-II D.P.C.
13.	Circumstances in which MPSC is to be consulted in making recruitment	As required under Manipur Public Service Commission (Exemption from Consultation) Regulations, 1972.
