**Subject: Reconstruction of Missing Gazettes – Invitation for Claims, Objections, and Suggestions**

No. ID-DPS-203/10/2025-DPS-DP&S: The Directorate of Printing and Stationery has been mandated with printing and publication of Gazettes for the Government of Manipur. Digitized records of gazettes have been uploaded on our websites, viz. <https://egazette.mn.gov.in> (for the period from 1947 to 2020), <https://manipurgovtpress.nic.in> (for the period from 2021 to 31<sup>st</sup> July, 2025) and <https://egazette Manipur.mn.gov.in> (from 1<sup>st</sup> August, 2025 onwards), However, certain gazettes are missing from the Directorate's records and could not be uploaded for public access.

2. To trace and digitize these missing gazettes, the Directorate is making all out efforts to obtain copies from the concerned Departments/Institutions of the Government of Manipur and Government of India. Newly recovered gazettes are being uploaded on the above websites from time to time.

3. In some cases, only the relevant notifications/orders/memoranda/circulars issued by the Departments/Institutions are available, though the corresponding gazettes are not. In such instances, the Directorate proposes to reconstruct the missing gazettes for public convenience and to meet legal and procedural requirements. These gazettes will be clearly marked as **"Reconstructed Gazette"** at the top or bottom of the document and will bear the **digital signature of the Director, Printing & Stationery, Manipur**, certifying their authenticity.

4. The Directorate hereby invites **claims, objections, comments, or suggestions** from the public and stakeholders regarding the proposed reconstruction of gazettes found missing, where the associated notifications/orders/memoranda/circulars are available with the concerned Departments/Institutions.

5. Submissions may be furnished to the Directorate by **12:00 midnight of 4th July, 2026** through any of the following modes:
