**No.LEM/M-3/26/2022-WR-WR:** In pursuance of the decision taken by the State Cabinet in its sitting held on 20-09-2022 and also in supersession of all previous orders issued in this regard, the Governor of Manipur is pleased to re-fix/revise the Irrigation Water Rates for realization from the beneficiaries for all types of irrigation schemes/ projects at the rates as indicated below with immediate effect in conformity with the fiscal reforms programme of Manipur (Reforms in non-tax revenue) subject to the following conditions as detailed below:
