For the purpose of equality and justice to all equivalent post sharing same nature of works and a common/combined seniority list etc., the posts of E.O(P), E.O(D), are required to be included as feeder cadre for Project Officer (MC), Junior Development Officer(JDO), so as to remove the irregularities and anomalies in the present promotional pathways among the equivalent posts.
